Personal Liability and
Medical Release Form B

I hereby agree to release M.I.T.E.S. and its representatives, agents, servants and employees from liability for any injury to the named person, resulting from any cause whatsoever occurring to the named person at any time while attending the M.I.T.E.S. Conference and Competition, including travel to and from the conference, excepting only such injury or damage resulting from willful acts of representatives, agents, servants and employees.

I do voluntarily authorize the M.I.T.E.S. personal to obtain medical services, assistance and/or designees to administer and/or obtain routine or emergency diagnostic procedures and/or routine or emergency medical treatment for the named person as deemed necessary in medical judgment. Parents/guardians of participant will allow emergency medical treatment to be administered as needed. Any further treatment will require parental/guardian consultation.

I agree to indemnify and hold harmless the M.I.T.E.S. personal and/or assistants and designees for any and all claims, demands, actions, rights of actions, and/or judgments by or on behalf of the named person arising from or on account of said procedures and/or treatment rendered in good faith and according to accepted medical standards.

Having read and understand completely the "Code of Conduct" of M.I.T.E.S., I do hereby agree to follow the procedures and practices described. I fully understand that this is an educational activity and will, to the best of my ability, apply myself for the purpose of learning and will uphold at all times the finest qualities of a person representing their school and M.I.T.E.S. Their school districts "Code of Conduct" will hereby be a guide for the participant and will agree and be responsible for abiding to their schools "Code of Conduct".

NOTE: All persons under legal age must have a parent or guardian sign this form (see M.I.T.E.S. Conference and Competition Personal and Liability Release Form). If you are age 18 or older, please indicate this on the M.I.T.E.S. Conference and Competition Personal and Liability Release Form. Otherwise, this form will be returned for a parent/guardian signature. All participants must sign this form.

Participants: Be sure you understand the "Code of Conduct" and your schools "Code of Conduct". Any persons violating these rules may be sent home at their own expense, may cause other contestants from their team to be sent home, or may otherwise disqualify their entry at the M.I.T.E.S. Competition.

CODE OF CONDUCT Agreement:

The M.I.T.E.S. is designed to be an educational function, and all plans are made with that objective. It is M.I.T.E.S. most significant meeting of the year, with many personal attending from all over the state. All personal are will be expected to conduct themselves in a manner best represents their school and M.I.T.E.S.

NOTE: All participants are not mandatory to attend the conference but voluntarily participating, you agree to follow the official conference rules and regulations or forfeit your personal rights to participate. We are proud of our organization and our students and know that by signing this "Code of Conduct" you are simply reaffirming your dedication to the best possible representatives of your school.

1. I will, at all times, respect all public and private property, including the hotel/motel in which I am housed.
2. I will spend each night in the room of the hotel/motel to which I am assigned.
3. I will strictly abide by the curfew established (10:30 in room, 11:00 pm lights out) and shall respect the rights of others by being as quiet as possible after curfew.
4. I will not remain in the sleeping room of the opposite sex unless the door is completely open at all times, unless the person is my spouse.
5. I will not use alcoholic beverages. I will not use drugs unless I have been ordered to take certain prescription medication(s) by a licensed physician. If I am required to take medication, I will have in my possession at all times a doctors orders stating permission.
6. I will leave the hotel/motel without damage by you or any other while you are assigned to that room.
7. My conduct shall be exemplary at all times.
8. I will not leave the hotel/motel without permission of my advisor/teacher/chaperone. I will also leave written notice of where I will be with my advisor/teacher/chaperone.
9. I will not smoke during the state conference/competition, unless one is of age. All school "Code of Conduct" states there is no smoking during school related functions.
10. I will attend, and be on time for all general sessions and activities that I am assigned to and registered for.
11. I will adhere to the dress codes at all required times.

Violations and Penalties

I agree that if, for any reason, I am in violation of any of the rules of the conference, I may be brought before the appropriate disciplinary committee or M.I.T.E.S. coordinator for an analysis of violation. I also agree to accept the penalty imposed on me. I understand that any penalty and reasons for it will be explained to me before it is carried out. I further realize that the severity of the penalty may increase with the severity of the violation, even to the extent of being immediately sent home at my own expense.

1. Violations of items 1 through 6 of the "Code of Conduct" will be grounds for immediate removal all awards, recognition and disqualification. In addition, the violator(s) will be sent home at his or her own expense. Notification of the violation and the action taken will be sent to the participant's parent/guardian, school and possible authorities contacted.
2. Violations of items 7 through 11 of the "Code of Conduct" will result in a warning and reprimand. Notification of the violation and action taken will be sent to the participant's parent/guardian and school. Repeated violations of items 7 through 11 may result in the participants being sent home at his or her expense.

Photography and Sound Release

I hereby grant the M.I.T.E.S. personal permission to make still or motion pictures and sound recording, separately or in combination, and also give a production company approved by M.I.T.E.S. permission to use the finished silent or sound pictures, and/or sound recording as deemed necessary. Further, I so hereby relinquish to the M.I.T.E.S. all rights, title, interest in, and income from the finished sound or silent motion pictures, still pictures, and/or sound recordings, negatives, prints, reproductions, copies of the original, negatives, recording duplicates and prints, and further grant the M.I.T.E.S. the right to give, sell, transfer and/or exhibit the same to any individual, business firm, publication, television station, radio station or network, or government agency, or any of their assignees, without payment or other considerations to me. My agreement to perform under camera, lighting and stated conditions is voluntary and I do hereby waive all personal claims, causes of action, or damages against the M.I.T.E.S. or its representatives thereof, arising from a performance or appearance.
